2. Status Report

A. Director of Parks

- a. Island/Park landscaping project
 - i. Parks probably need new mulch for \$600, which the Board approved
 - ii. Joe has cleaned spray paint off of the playground
 - iii. Mike will inform Brent at security about the graffiti
- b. Trees
 - i. The oaks on Meyer and Greenway Terrace have been trimmed
- c. Lawn cutting of the 3 islands
- d. Empty waste basket at 63rd
 - i. JT and Joe are providing this service
 - ii. Wendy will try to find a lid for the trash can
- e. Meyer Columns
 - i. Katie (former president) had looked into the amount of money it would take to restore the columns on Meyer Boulevard
 - ii. These columns are historic, so PIAC offered \$28,000, which leaves us \$30,000 or so to come up with (\$88 per house)
- f. Sidewalks at Greenway Terrace
 - i. Pushed back until August 2008, which means that area won't be landscaped until 2009
 - ii. There are fencing problems at the boundary, but when the City performs its work, it will perform a survey and put the fencing back in the correct spot

B. Director, Safety and Security (Mike)

- a. Snow Removal (Joe)
 - i. Expensive so far for year
 - ii. KCMO has said it may remove snow removal from its budget for 2008
- b. Security Patrol (Mike)
 - i. Board engaged in long discussion over pros and cons of continuing with Brent (with KCMO PD) versus private security companies
 - ii. Based in large part due to Brent's late response times, lack of monthly reports
 - iii. Gina feels to many people are involved and this should be minimized so that Brent really becomes responsible to one or two people

- iv. Joe hasn't had problems getting a response from Brent
- v. One of the pros of having a security company is that when people see the car, they know their money went for that car
- vi. The pros of having off-duty police in marked cars is that people are more intimidated by police presence, the police have the option to arrest and run background checks
- vii. For now, the Board will remain with Brent
- c. Sewers/Water Project (Barbara)
- d. Mobile Page
 - i. There is a program in Kansas City called Mobile Page, which is a service where homeowners can register (or they can be entered into a database) so that they automatically receive a message that the board wants to leave for them
 - 1. Examples include monthly information and security alerts
 - 2. The cost is cheap \$10-\$15 for a call (to 343)
 - 3. There is also the option of leading with an advertising to help with costs, but the Board didn't like this idea

 - 1. Barbara offered to call homeowners first (she has to get the number from HACCD) to welcome and offer to put in newsletter
 - ii. Printing in color is more expensive
 - iii. Preparing a home directory also causes privacy concerns

E. Neighborhood Events

- a. Annual Meeting
 - i. Low participation in 2008
 - ii. Board wants increased participation from homeowners for next year.
 - iii. Ideas make pancakes in the street during a weekend morning (determine best time to do so) some like Chris Cakes, some don't
 - iv. Have it at Charlie Hoopers or similar place
 - v. Combine with holiday party
- b. Annual Picnic
 - i. Board does not think the clown lady was good

- ii. There is a very good balloon artist
- iii. Kids love the fire truck
- iv. May have the moonwalk next year (costs \$75), but we need to use a neighbor's yard to do so
- v. Board would also like to consider having a jazz singer (like Cynthia Van Roden(sp?), one of our homeowners
- c. Holiday Party
 - i. Low turnout at Holiday Party, due in large part to weather
 - ii. Board received complaints that no kids allowed at Holiday Party
 - iii. Could be good to have a separate area for kids with pizza
- d. Garage Sale
- e. Holiday Lighting Contest
- f. Home of the Month
 - i. Seems to be working well
- g. Welcome new Homeowners
- h. Popsicle Parade
 - i. Need to see if Linda Vogel needs to be reimbursed for popsicles (there are questions over whether the popsicles are typically paid for by the host)
 - ii. We have money in the budget to reimburse for popsicles
- i. Hazardous Waste
 - i. We cannot get dumpsters for hazardous waste without guaranteeing a huge amount, so this is not an option
 - ii. JT volunteered again to provide a truck
 - iii. Time period for pickup should be short this year, like 9-11 instead of 9-1
 - iv. There is another pickup scheduled for August 2 at 95th and Ward Parkway
 - v. We must remember to check with the grocery stores to get boxes
- i. October Event
 - i. Joe mentioned the idea of having a community event during October and blocking off a street (like a block party, but a neighborhood party)
 - ii. The idea is to have a pumpkin carving contest where people bring their own supplies
- F. Covenants, Bylaws, and Dues (Aaron, Mike)
 - a. Recap
 - b. Determine opportunities for change
 - i. Board discussed whether making dues legally enforceable is worth the effort considering the amount of homeowners who pay the increased voluntary dues
 - ii. Board decided it is likely worthwhile
 - c. Dues
 - i. Gina and Joe have received a total of 3 phone calls complaining about the increased dues
 - ii. Currently, the total amount of the homes that are late equals \$15,700
 - iii. Redbridge's newsletter had good examples of how to approach this issue
 - iv. Threshold for filing a lien will be \$300.00
 - v. May be a good idea to put the approval for amending the Agreement in the newsletter so people can mail their approval
 - vi. Talked about having the legislature enact a bill that allows amendments

 - ii. For the next security statement, homeowners will only be billed \$10
