Approval of Board Meeting Minutes

Neighborhood Website

Neighborhood Beautification/Improvement

The Board will nominate homes for the June 'Yard of the Month' winner. The winner will receive a \$20 gift certificate from Suburban Lawn & Garden.

- Homeowners who won in 2011 have to wait at least one year to be eligible to win again.
- Winners will be posted on Facebook.
- Steve Rinne will contact Rosehill Gardens to see if they would be willing to donate additional gift certificates to our Association.

Signal Light at Carnoustie & State Line

• Board voted to keep this item on the Board Meeting Agenda since we have been approved for Public Improvements Advisory Committee (PIAC) funds through which a sensor can be appropriated to regulate the light.

Island Maintenance

- Alan Gallas will request Ultra Lawns to submit a bid for 2012 Island Maintenance.
- Mindy Clarke will also solicit additional 2012 Island Maintenance bids.
- Depending on the pricing received on the maintenance bids, the Board discussed paying willing homeowners located near islands to do the maintenance for the island near them. This would include mowing, trimming, watering, weed removal, fertilizing, etc.
- The tree located immediately behind the west Blue Ridge entrance monument is dead and will be removed and replaced with a new tree. The homeowner nearest the tree agreed to water and maintain the new tree.

Treasurer's Report

- Karen Wood-Nelson presented the Treasurer's report through April 30, 2012.
- Blue Hills Estates fiscal year ends June 30, 2012.

Neighborhood Nuisances

- If you are a parent, please be mindful of the whereabouts of your children and instruct them to respect other homeowners' property and to be aware of the hazards of playing/walking in the street.
- Complaints persist about cars parking around the cul-de-sacs and along the street on St. Andrews Drive. Please be aware that street and cul-de-sac parking may result in the receipt of a traffic citation from the City. Please park in your driveways

Public Improvement Advisory Committee (PIAC)

- The Public Improvements Advisory Committee (PIAC) requests submitted by Steve Rinne in 2011 are still active. We are awaiting word on their status.
- The PIAC application process for 2012 begins in July.

Signing up Non-Association Members

- There are currently ten (10) homeowners in Blue Hills Estates that are not members of the Blue Hills Estates Homes Association and, as a result, do not pay the \$75 annual Association Dues. They are getting all the benefits of the Homes Association without paying any dues. Since our dues are capped at \$75 a year and costs keep rising, the Board would like all homes in Blue Hills Estates to join the Association and pay the annual dues.
- Steve Rinne will contact these homeowners and ask them to join the Association.
