 1 is a long-time delinquent case with a lien having been filed, 3 have had Notice of Lien Letters, 3 owe greater than \$100—same residents as reported in February's Treasurer's report. As of last report 24 owe, now 19, 5 of these have started to pay their balance.

It was decided foe Ed to draft a letter to all the homes informing them of this great communication tool and asking for their email addresses.
