## **WESTMONT BOARD MEETING MINUTES -- August 18, 2025**

**President:** John Z. called the meeting to order and welcomed everyone.

Precision Lawn's contract was approved by the Board for three more years. (Note: Precision Lawn said that he will not be able to plow snow from driveways that are in poor condition because it ruins the plow blades.)

#### **Vice-President:**

- 1. Larry announced that ARC forms are still being turned in for several projects and are being approved. There are several driveways being replaced on 119<sup>th</sup> Terrace.
- 2. Larry T and John R will be performing inspections during the month of September. The goal is to help homeowners identify exterior problems to be corrected, which will maintain all of our property values and keep the community looking its best.

# **Treasurer:**

- 1. Financials are all in order for July.
- 2. Only one homeowner remains in lien status. There are 6 homeowners with unpaid fees of only one or two months. All are being monitored and/or contacted for follow-up.

Secretary:

Larry made a motion to accept the Minutes of the June Board Meeting. John R. seconded. Minutes were approved unanimously.

## **Lawn and Ground Chairman Report:**

- 1. Mark at Precision Lawn has hired an Administrative Assistant to help him, so he can spend more time in the field with his teams.
