Please contact Tim Kennedy if you need a pool key. Each household is issued one keycard. If it is lost, it can be replaced for \$10. The lost key number will be deactivated.

Upgrades – This winter we replaced the coping and tilework around the pool, installed a new pool pump, had the outside of the poolhouse refurbished and repainted and had new gutters installed.

NEWS and reminders from the BOARD:

• **Pedestrians** – With the lockdown in place many more people have been out walking on the streets – Please keep an eye out for traffic.

Drivers – Please slow down and give walkers / cyclists a wide berth.

• **Mowing** – When mowing the perimeter of front yards, please mow so the grass is thrown back onto the yard rather than in the street. Not only does it keep things looking tidier, but it minimizes grass cuttings and fertilizer from working their way into the storm drains and into the ponds in the neighborhood. The ponds are not in great condition, but additional grass and fertilizer run-off makes the algae bloom out of control.

• **Yard maintenance** – Please keep your grounds well maintained and free of excessive trash and brush. Brush should be burned or removed annually. The Johnson County Fire District #2 station #81 at 19120 Metcalf covers our neighborhood and will issue 30 day burn permits. When burning, please do not burn wet leaves or brush that cause excessive smoke.

• **Roofs / garages / home additions / fences** – These all need approval from the architectural committee. When planning any of these improvements, please bring it to our attention early, and we will help residents through this process.
