#### **DEED RESTRICTIONS**

In order for a neighborhood be to a good place to live, neighbors need to act neighborly. This means communicating with your neighbors, even when you are not in agreement on something. One of the most common calls or emails we receive as board members is when one neighbor is complaining that another neighbor has built or installed something in their back yard. Rarely have the two neighbors talked.

When someone buys a home in Kenilworth, they receive a welcome package from Homes Association Kansas City, HA KC. In that package is a copy of the most recent Kenilworth directory. That directory provides a summary of contacts, services, and restrictions that apply to Kenilworth homeowners. The restrictions are important to know.

#### **Kenilworth Restrictions**

Home improvements are always desirable since they add value not only to the individual residence but also to the neighborhood. If you are considering any type of modification to your property, such as adding a patio, installing a fence, or adding to the "footprint" of your property in any way you must consider the Deed Restrictions applicable to our neighborhood. It should be noted also that compliance with the Deed Restrictions is independent of City Building Code requirements. Two distinct reviews are involved. Obtaining a Building Permit from the City does not indicate that homes association Deed Restrictions have been considered or have been met. A complete set of Deed Restrictions can be obtained from the Homes Association Office located at 4200 Somerset Drive, Suite 216 Prairie Village, KS 66208 - phone 913-385-2440

For Deed Restriction review, submit your plans to Sam Wilson, Executive Director of the Homes Association at the office noted above. His review will be for compliance with Deed Restrictions only. If the proposed plan is not in compliance and requires a variance, the plans will be passed along to the Kenilworth Board of Directors for review and acceptance or denial of the variance. A written response will be provided to the resident indicating approval or denial of the request.

#### JERRY FLADUNG BENCH

Rosemary Fladung and family (sitting on the Jerry Fladung memorial bench at 96<sup>th</sup> and Linden) were presented with a Certificate of Dedicated Service. Jerry was a board member for over 40 years and originally arranged for installation of this bench for

the children waiting for the school bus. A plaque has been placed on the bench after being refurbished honoring Jerry.



#### **ISLAND MAINTANANCE**

Thank you to those who maintain the Kenilworth Islands. If you wish to be reimbursed for your annual cost (up to \$100.00 per island) please send receipts to our Treasurer, Floyd Wohlrab.

Volunteers are needed for the maintenance of the Kenilworth Island located at 96th St. and Linden.

Maureen Gamble maintained the Island for 25 years. Please take time to read Maureen's experience and her request.

"We all take pride in our homes and landscaping is an important part of our homes' look. As people drive to our homes, they pass the islands that are designed to reflect the quality of our neighborhood. For more than 25 years, I tended three islands in our Kenilworth neighborhood and considered it important to the look we present to visitors. I retired from this three years ago and no one seems interested in caring for the island at 96 St. and Linden and it shows. This island stands out for its weeds and sad looking, untrimmed shrubs. Once it is cleaned up, this island should require no more than 30 minutes a week to maintain. It is a joy and a real satisfaction to keep it looking nice. You meet neighbors you didn't know as people always stop and thank you for your efforts!" -Maureen Gamble
