
Pond Committee News

Hello to my NWT neighbors!

The Northwood Trails Homes Association Board of Directors and the volunteer committees had a challenging 2024, but ultimately met the goal of



keeping all of our shared amenities in good repair and operational within our budget.

Inflation has slowed lately, but costs remain historically high for services (pool systems management, pool house plumbing, common area irrigation system work, mowing, trimming, tree care), supplies (pool and pond chemicals) and utilities (electricity, water, wastewater).

At the same time, the board is planning for deferred maintenance projects such as the replacement of one of the pool heaters, as well as infrequent, but costly, maintenance projects such as the replacement of the pool liner surface.

The Board voted in October to keep NWT Homes Association membership dues flat in 2025 at \$660 per home with late fees accruing beginning May 1 and an early-pay discount.

The Board has held lengthy discussions on the budget in recent months and hopes to avoid replicating the financial crunch of the post-COVID era when long-steady membership dues became insufficient to maintain our neighborhood. To that end, in 2026 and beyond, the Board plans to align membership dues more closely with annual inflation, ideally via small yearly increases.

Wondering how to contribute ideas on using and conserving neighborhood resources while maintaining our shared amenities? Join one of the volunteer committees that make NWT a sought-after neighborhood. Architectural Review, Treasury, Grounds, Pond, Pool, Social and Welcoming committees all need extra hands of any age, but especially some younger brains for ideas, organizing and legwork; plus, it wouldn't hurt to have some younger muscles to help with the occasional improvement projects committees tackle themselves. The time commitment is minimal, but the rewards — admiring and taking pride in the improvements to your first-rate community and showing young neighbors the value of volunteering — are immense.

Next spring, we will be looking at sections of our trails



Social Committee would like to thank all the volunteers who set-up, cooked and cleaned up our annual



This month's deed restriction refresher is No. 10 on the matter of animals: "No animals, livestock or poultry of any kind shall be raised, bred or kept on

any lots, except dogs, cats or other household pets, provided they are not kept, bred or maintained for any commercial purpose and do not constitute a nuisance to the neighbors or neighborhood. The Homes Association Board of Directors shall have the authority to determine what constitutes a nuisance. Upon such determination, such animal will be removed

from the subject lot within three weeks of notification to the owner thereof of such determination or, in the event that a further determination is made that there is a potential for danger from the animal, then within 48 hours of such notification."
