Information Sharing

When an email is sent sharing information regarding a crime in the HOA Community. Please share camera footage with those who may have been victimized in the HOA Community. This will assist the KCPD investigate the crimes committed in the HOA Community and possibly solve a crime.



1. How should I handle seeing someone has dumped trash or tires on our surrounding properties on Bernard Powell, Jackson or Cleveland?

Answer: You should call 311 to report the dumping and request removal (Pictures are always helpful and can be sent Via the 311 Reporting App). 311 will take that report and send out workers to have the trash and tires removed.

2. Homeless Trespassing how is this handled?

Answer: If Homeless trespassing is on private property of Renaissance Place, we should call 911 and report to have trespassers removed. (Pictures are always helpful and can be sent via the 311 APP or online.).

If you notice a homeless camp that has been set up and is <u>not</u> on Renaissance property, how should it be reported?

Answer: You should make a report to 311.

3. What should I do If I notice a suspicious person looking in my window?

Answer: You should make a report to 911.

4. If you notice a suspicious person sitting in a car in the neighborhood, how should it be reported:

Answer: You should make a report to 911.

5. If I see a suspicious person going house to house or soliciting, how should I report?

Answer: You should make a report to 911. We have <u>no</u> solicitation signs posted in entrance areas of Renaissance Place Homes Association.

6. How should I report illegal parking and a car seems suspicious?

Answer: You should report it to 911. If you can get license number (pictures), it would be helpful to the KCPD. A picture with a license number would be very beneficial.

7. Can I report soliciting to the non-emergency reporting number?

Answer: Kansas City has a **No Soliciting Ordinance** that allows homeowners to post signs to deter unwanted solicitations. If you suspect a scam, report it to local authorities and **avoid** engaging with suspicious solicitors. Renaissance Place Homes Association has signs posted at the entrance of the HOA **of no soliciting.**

Safety Emergency Numbers

816-234-5111 for this <u>non-emergency number</u> what type of incident should be reported:

The non-emergency number 816-234-5111 for the Kansas City Police Department is for reporting incidents that do not require immediate police presence. Examples include:

Property crimes (e.g., theft, vandalism)

Suspicious activities (e.g., someone loitering)

Traffic incidents (e.g., minor accidents without injuries)

Lost or found property

Noise complaints

<u>311</u>

The non-emergency number 311 is typically used for reporting issues that don't require immediate police or fire department response. Examples include:

Public Works issues (e.g., potholes, streetlight outages)

Sanitation concerns (e.g., garbage collection, illegal dumping)

Parks and Recreation issues (e.g., park maintenance, playground repairs)

Noise complaints (e.g., loud music, construction noise)

Animal control (e.g., stray animals, animal bites)

Code violations

Illegally Parked vehicles

Speeders

Homeless trespasser (camps) not on Renaissance Property

What should be reported to E911?

E911 (Enhanced 911) should be used to report emergencies that require immediate police, fire, or medical response. Some examples of situations to report to E911 include:

Medical emergencies (e.g., heart attack, stroke, severe injuries)

Fires (e.g., building fires, wildfires, gas leaks)

Crimes in progress (e.g., burglary, assault, robbery)

Traffic accidents with injuries

Natural disasters (e.g., tornadoes, floods, earthquakes)

In short, if the situation is life-threatening or requires urgent attention, you should call E911.

MAIL THEFT

If you've experienced mail theft in Kansas City, Missouri, you can report it to the **United States Postal Inspection Service**. They handle mail-related crimes and offer an online reporting form.

You can also call them at 1-877-876-2455.

Additionally, if you suspect a USPS employee is involved in mail theft, you can report it to the U.S. Postal Service Office of Inspector General through their complaint portal. https://hotlineform.uspsoig.gov/en-US/

For broader criminal investigations, you may also contact the Kansas City FBI Field Office at (816) 512-8200 or submit a tip online. https://www.fbi.gov/contact-us/field-offices/kansascity

If the theft is happening in real time or involves other serious crimes, calling **911** is the best course of action.

SCAMS

What are some of the residential Scams that are being solicited to, door to door neighborhoods in Kansas City?

Kansas City residents should be cautious of various door-to-door scams that have been reported in neighborhoods. Here are some common ones: **Fake Home Security Sales**: Scammers pose as representatives from well-known security companies, claiming they need to inspect or upgrade your system. Once inside, they may gather information about your home's security setup for future burglary attempts.

<u>Fraudulent Home Improvement Offers</u>: Some scammers offer services like roofing, driveway repairs, or tree trimming, demanding upfront payment but never completing the work.

<u>Utility Switching Scams</u>: Fraudsters may claim they can lower your utility bills by switching providers, often using deceptive contracts or unauthorized financing documents.

<u>High-Pressure Sales Tactics</u>: Scammers use aggressive techniques to push overpriced or unnecessary products, often targeting elderly residents.

Kansas City has a <u>No Soliciting Ordinance</u> that allows homeowners to post signs to deter unwanted solicitations. If you suspect a scam, report it to local authorities and avoid engaging with suspicious solicitors. **Stay vigilant!**
